

“How much land does Sime Darby want?”




“After the 63 years, will they give our land back to us?”

“**No**, The land will be with Sime Darby for 63 years. After the 63 years, if they want to go back to Malaysia, they will give all the land, palm, rubber and houses in the Concession Area to the government before they go.”⁴

“But, I hear they say Sime Darby will plant the palm on our land, and the palm will be for us.”

“The contract says they will pay US\$5 per hectare for the land that they plant oil palm or rubber on. But the contract says that the government and Sime Darby will form a committee to manage the money. Maybe some of the money will come to your community, but the contract does not say so.”⁵

“**No**, that is not true. The government first needs to find the money for Sime Darby to do that; if the government does not find the money – Sime Darby will not plant palm or rubber for you.”⁶


“After the 65 years, will they give our land back to us?”
